General Information

- SAFETY FIRST!

While on Association grounds, always conduct your behavior in a safe manner. Be considerate of others and their safety as well. Practice any unsafe behavior and you will be asked to leave immediately.

- Please read this packet in it's entirety before completing the application form.
- Event will be held at the East Berlin Fish and Game Association grounds June 21, 2025.
- Event will be held rain or shine.
- Event is free and open to the public.
- Parking is available at the facility.
- Entrance and exit to the event will be through the main building vestibule only.
- Event check-in will begin at 09:00.
- **FIREARM MUST ALWAYS BE POINTED UP!** After you exit your vehicle, insure your firearm is unloaded and safe before approaching the event entrance.
- **Participant must have eye and ear protection - no exceptions.**
- **Do not bring ammunition** - ammunition will be supplied by the event coordinator.
- Your assigned participant number tag must be on your outer clothing and clearly visible at all times while at the facility.
- Guardian should have ID ready prior to approaching event check-in.
- Mail your completed application timely; late, lost or not received applications will not be credited.
- You can bring your completed applications with you the day of the event, however you are encouraged to mail your application. Pre-registration will expedite processing at the event check-in.
- Our kitchen will be open throughout the event.

Event Rules

Please read **all** rules carefully.

1. This event is open to the public.
2. Ages for this match are: eight (8), to sixteen (16) years old.
3. All shooters **MUST** have a parent or guardian at least twenty one (21) years old accompanying them at all times.
4. Adults are responsible for the shooters actions and safety at all times.
5. A **mandatory** safety briefing will be conducted at 10:00 am. All adults and shooters must attend. **NO EXCEPTIONS.**
6. Rifles that are “stock” (not highly modified) and chambered in .22 LR (long rifle), will be allowed to participate. Open sights, ie., traditional buck horn, or peep sights as well as scopes will be permitted. However, all scopes will be adjusted to a max of 1x magnification regardless of the full range of the scope.
7. ALL rifles will be cleared, inspected, and have a chamber flag inserted **BEFORE entering the building.**
8. This is a double elimination match. Winning shooters will progress through a winners bracket. All others will compete in the second chance bracket.
9. There will be two (2) practice rounds fired by each shooter to verify their zero. At each stage, five (5) rounds will be fired at the target, one at a time, within 5 seconds for each round. The best five (5) shot group determines the winner.
10. Targets will be evaluated and scored by the Match Director. All decisions by the Match Director are final.

Release, Waiver, Indemnification, Hold Harmless and Assumption of the Risk Agreement

In consideration for participating in club activity sponsored or organized by the East Berlin Fish and Game association, the undersigned Participant **HEREBY AGREES TO WAIVE, RELEASE, DISCHARGE, AND HOLD HARMLESS** the East Berlin Fish and Game Association from any and all claims for damages for death, personal injury, or property damage which they may have or which they may hereafter accrue as a result of participation in any East Berlin Fish and Game Association program or related activity and events including, but not limited to unorganized practice, organized practice, training and instruction and organized shooting events.

By signing this Release and Hold Harmless Agreement, the undersigned recognizes that the sport of rifle, pistol, and shotgun shooting or related activities present certain inherent dangers that cannot be eliminated even by the exercise of reasonable care. As such, the undersigned Participant hereby expressly assumes the risk that is inherent to the sport of rifle, pistol, and shotgun shooting.

As a requisite condition to the Participant being allowed to attend and participate in any East Berlin Fish and Game Association. Sponsored event or trip, the undersigned Participant hereby acknowledges that the State of Pennsylvania has the most significant relationship with the parties to this Agreement rather than the destination state or providence. As such, the parties hereto expressly agree to Pennsylvania as the Choice of Law and Choice of Forum to any claim, suit, or controversy that may arise by and between the parties or any of its related affiliates, and further agree that any action, suit, or claim made by the Participant must be brought in the State of Pennsylvania as the proper Venue having exclusive subject matter jurisdiction to any such claim, demand, or suit. To effectuate this expressed Choice of Law, Choice of Forum and Venue provision, the undersigned hereby agrees that the state or providence where the injury or cause of action arose shall not have either subject matter jurisdiction or in personal jurisdiction over the parties hereto.

By signing this Release and Hold Harmless Agreement, the undersigned Participant assumes the risk inherent to rifle, pistol, and shotgun shooting, and thereby consents to the Participant's participation in East Berlin Fish and Game Association. programs and related activities, and further acknowledge that he/she understands that all risks, whether known or unknown, are expressly assumed by the undersigned, and that all claims, whether known, or unknown, are expressly waived in advance.

In addition to the foregoing, the undersigned Participant hereby expressly agrees and recognizes that the East Berlin Fish and Game Association., through its individual Directors, Chairmen, Range Officers, judges and referees, officers, directors, agents, individuals, Certified NRA Instructors or entities perform volunteer services, and as such, said entities and/or individuals are immune from liability as volunteer leaders, assistants, and organizers.

Mandatory Binding Arbitration

In further consideration for being allowed to participate in any activities sponsored by the East Berlin Fish and Game Association. the undersigned Participant recognizes and agrees that this contract involves interstate commerce which is necessarily controlled by the Federal Arbitration Act (9 USC § 2), and therefore, pursuant to the Federal Arbitration Act (FAA) hereby agree to submit to binding arbitration any and all claims, demands, suits, or other disputes that may arise out of this contract, or that may be presented by or on behalf of the Participant for resolution under the Commercial Rules of the American Arbitration Association with the initial filing fees thereof to be paid by the party filing the Demand for Arbitration subject to the schedule of fees then in effect at the time of the filing of a Demand with the American Arbitration Association.
